PROCEDURES

Surgical Biopsy – Histopathology

Any species, fixed tissue only. Note: Fixed tissues from deceased animals (i.e. NOT surgical biopsies) will be considered a bottle necropsy.

*Multiple animals per submission policy:

- Mammals: Up to 3 fetuses/neonates from the same litter may be included as one necropsy fee.
- Poultry from commercial flocks (NOTE: Premise ID required): Up to 5 birds from the same age/group may be included as one necropsy fee.
- Commercial fisheries: Up to 5 fish from the same age/group may be included as one necropsy fee.
- Tissues will be pooled at pathologists discretion. Additional fees may apply.

* WVDL requires a legal entity (Police Department, Animal Welfare Officer, District Attorney) to be associated with all forensic/legal cases submitted to WVDL. Body retention is limited to six months.

Animal Carcass Disposal

Some animal carcasses and tissues require incineration or digestion as a disposal method. More information on our rendering policies can be found on our website under Diagnostic Resources. Composting available only for non-barbiturate euthanized domestic animals.

Cremation of pets – Madison and Barron Laboratories

- Clients must arrange all cremation services and provide a cremation order form along with the Necropsy Submission Form when the body is dropped off for necropsy. Companies that have scheduled pick-ups with WVDL are Trusted Journey Pet Memorial Services (Madison and Barron locations) and Memorial Pet Service (Madison location only). Other cremation options may be used, however, WVDL does not ship remains to crematoriums, remains must be picked up by the company.
- Large animal private cremations – Limited to Head, Heart, and Hooves unless special approval is granted

Research Requests

The fee structure above does not apply. Routine WVDL diagnostic pathology services do not include research studies. Research studies may be possible to arrange with individual WVDL pathologists on a case by case basis, as part of scholarly activity, with the expectation of co-authorship on peer reviewed scientific publications. WVDL may also choose to perform ad-hoc histopathology services received for submission on our Histopathology Research Submission Form.
